AMENDED ARTICLES OF INCORPORATION

I, the undersigned, hereby organize a NONPROFIT corporation pursuant to the laws of the State of Arizona, Title 10, Chapters 24 through 40 and adopt the following Articles of Incorporation:

1. The name of the corporation shall be **LOVE AND LUCK, LOVE AND SMILES, INC.** The existence of this corporation shall be perpetual beginning with the date of filing of these Articles.

2. The principal place of business and initial offices of the corporation shall be 4 8376 N Basilio St, Gold Canyon, AZ, 85118-0828.

3. The purpose for which the corporation is organized and the operation of its business shall be to receive and administer funds for charitable purposes as a nonprofit association in compliance with Sections 501(c)(3) and 527 of the Internal Revenue Code. The corporation shall be subject to all of the laws of the State of Arizona pertaining to not-for-profit corporations.

4. The name and resident address of the incorporator is Clint W. Smith, 4110 N Scottsdale Road, Suite 170A, Scottsdale AZ 85251.

6. The affairs of the corporation shall be conducted as shall be specified by the By-Laws of the corporation. Once fully organized, the Board of Directors shall number at least five (5).


7. The stockholders, officers and directors, shall not be individually or personally liable for the corporation's debts or other liabilities, and the private property of such individuals shall be exempt from any corporate debts or liabilities.

8. Every director and every officer of the Corporation shall be indemnified by the Corporation against all expenses and liabilities reasonably incurred by or imposed upon him in connection with any proceeding to which he may be a party or in which he may become involved, by reason of his being or having been a Director or officer of the Corporation, whether or not he is a Director at the time such expenses are incurred. This right of indemnification shall be in

addition to and not exclusive of all other rights to which such Director or officer may be entitled.

9. This corporation does hereby appoint KATETHLEEN B. SPAETH, 48376 N Basilio St, Gold Canyon, AZ, 85118-0828, who has been a bona fide resident of the State of Arizona for at least three (3) years, its lawful Statutory Agent, and by the signature below, he consents to act in this capacity until removal or resignation in accordance with Arizona Law.



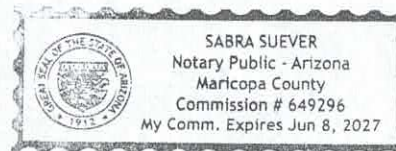
